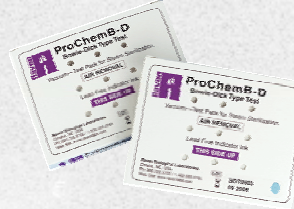

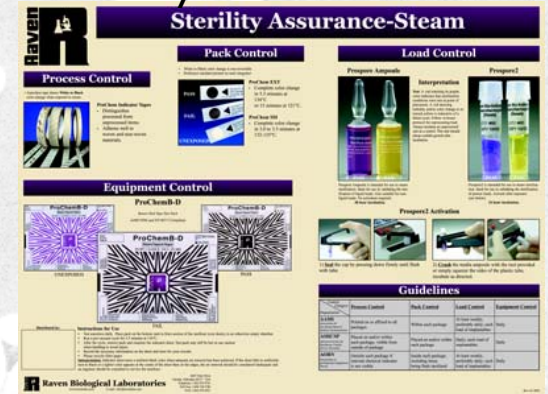


Certification
