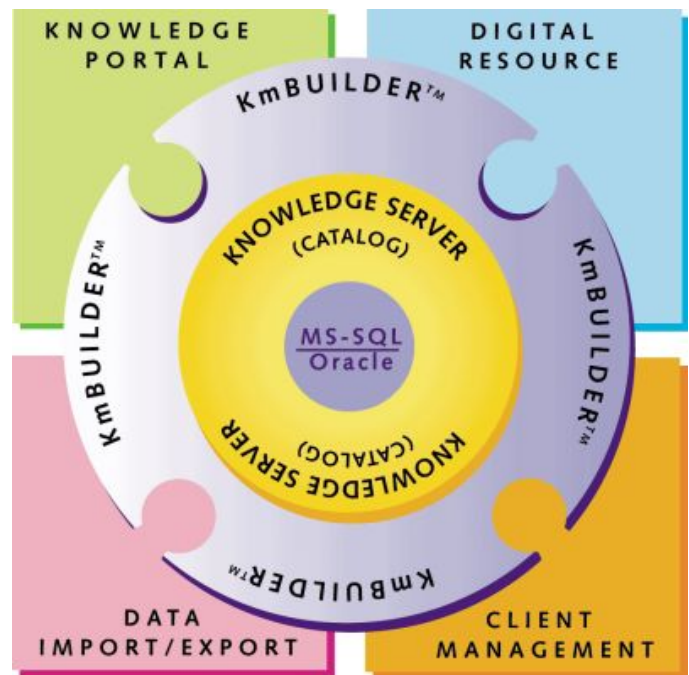

The Client Management module improves efficiency by accelerating response time to information requests, eliminating redundant activities and tracking research time and costs.

Smart organizations eliminate redundant or non-value-added activities. If multiple users make the same information request, for example, this duplication of research effort costs time and money. The Client Management module eliminates duplicate research effort and improves staff efficiencies. It builds a database of commonly asked research questions (including the answers and their sources), which in turn minimizes research time. It also allows the knowledge center to make more informed purchasing decisions based on an understanding of what type of knowledge and research is most frequently requested by clients.

When a file is read into the *SydneyPLUS* database, the meta-data is automatically detected and added to the record
- **Users can only search on a limited set of meta-data:** Because other systems only allow you to attach files to catalog records, your users are limited to searching those records to find files. *SydneyPLUS* uses full text searching, allowing you to keyword the entire contents of MS-Office or PDF files, so your users can locate any documents that contain data relevant to their needs

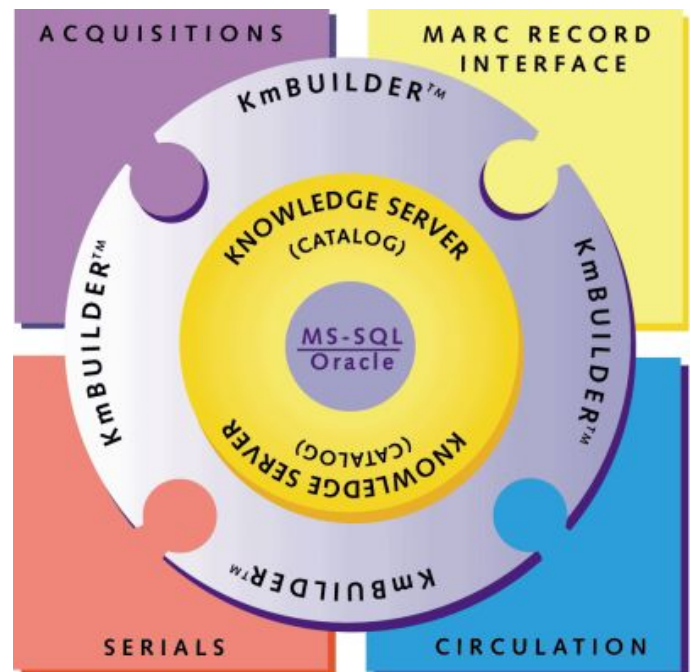

## Serials

Serials are one of the largest investments a company makes in knowledge resources. Many large firms spend hundreds of thousands (if not millions) annually on paper and digital subscriptions, yet they have no way of tracking whether this is money well spent.

The Serials Module is a powerful tool for simplifying serials management. Clients who use this module invariably report that they have reduced costs and freed up staff time to focus on higher-level tasks. They also report that they have saved money by finally being able to identify and eliminate duplicate, unauthorized or unread subscriptions.

### Basic features

- Automates labor-intensive serials tasks.
- Manages:
  - Publication schedules
  - Subscriptions and Renewals
  - Copies, including different copy types (routing, keep, bound, etc.), and location specific copies
  - Issue check-in and Claims

- Produces reports tracking issue/copy use, claims, etc.

## Acquisitions

The Acquisitions module improves purchasing decisions and helps you better manage costs through detailed reporting on the financial operation of your information center.

It is essential to manage costs, keep an eye on the bottom line, and make better use of purchasing dollars, but you can only manage that which can be measured.

The Acquisitions module is a powerful financial tool. It improves purchasing decisions because it lets you efficiently track and manage costs. One of our clients, for example, found cost-savings of 10 percent after using the Acquisitions module to manage subscriptions. Flexible and adaptable, the system also promotes conscientious spending by tracking purchases at the agency, department, individual and project level.

### Basic features

- Record keeping (track orders, invoices, etc.)
- Create multi-item orders
- Budgeting, tracking costs centers (accounts) and expenses
- Automate ordering process and cost tracking.
- Manage receiving
- Claim late orders
- Produce reports to track costs, budgets, claims, etc
- Order and claim reports can be directly emailed to suppliers

## Circulation

The Circulation module reduces costs by streamlining information sharing across the enterprise.

Organizations invest in information—in books, reports, journals and other resources—but this investment only has value if it is used and shared. Information can also be expensive, and organizations need to ensure that their knowledge investment is spread among as many users as possible.

The SydneyPLUS Circulation module addresses these two key business needs. It streamlines the information-sharing process, improving the availability of resources because their exact whereabouts are always known. It directly contributes to reduced costs, as acquisitions budgets can be stretched when resources are more effectively shared with greater numbers of users.

### Basic features

- Perform all basic transactions (check-in, -out, reserve, hold) with a single mouse click
- Track statistics and produce reports on resource use
- Check-in and -out operations can be configured to use either manual data entry, or barcode reader (for high-volume)

### Pervasive problem solutions

- **Complex interfaces slow down the circulations desk:** Our single-screen interface allows users to access all circulation functions from one location, making even a diverse series of transactions quick and efficient to process
- **Frequent circulation transactions take staff's time away from other duties:** SydneyPLUS can be configured to allow library users to enter their own checkout transactions. Staff can devote their time to other duties, and batch-process check-in transactions at their convenience
- **Efficient to process overdues electronically, but still time consuming to manually follow-up with phone/fax/email/memo:** SydneyPLUS reports can be configured for automatic distribution by email. Simply run the overdue notice (or equivalent) report, and notices are immediately emailed to all users with current overdues

## MARC Record

The MARC Record Interface saves time and costs when creating a high-quality and accurate catalog of your organization's knowledge resources.

Your online catalog is the most visible aspect of your library, so the sooner it is up and running, the better. The MARC Record Interface ensures fast implementation, high quality records and reduced costs compared to manual data entry. The result is an up-to-date and accurate catalog quickly available to your users.

### Basic features

- Converts downloaded MARC format records into SydneyPLUS formatted records
- Populate your catalog with high quality (AACR 2) bibliographic records without entering any data manually
- Mapping table allows you to route data to the SydneyPLUS field of your choice, and can manipulate data to better fit your formatting requirements
- Preview records before saving them to ensure data integrity
- Create new records, or match and overwrite existing records in the system. Record matching can also be used to prevent duplication

## Full MARC Catalog

Some databases are required to keep their records in MARC format. For those users we have our Full MARC module. This module allows you to take advantage of both the high precision and universality of MARC records and the advanced functionality of SydneyPLUS.

- Populate your catalog with high quality (AACR 2) bibliographic records without entering any data manually
- Mapping table allows you to route data to the SydneyPLUS field of your choice for display purposes
- Preview records before saving them to ensure data integrity
- Create new records, or match and update existing records in the system. Record matching can also be used to prevent duplication.
- Use the mapping table to route records to the appropriate SydneyPLUS template automatically

### Pervasive problem solutions

- **Acquisition of detailed records:** Our MARC catalog includes our Z39.50 search engine. This feature allows you search for existing MARC format records and download them directly into your SydneyPLUS database. Cataloging has never been simpler
- **Keeping MARC and non-MARC data in the same database:** SydneyPLUS allows you to have both MARC and non-MARC templates in the same database. You can even have mixed MARC and non-MARC records.
