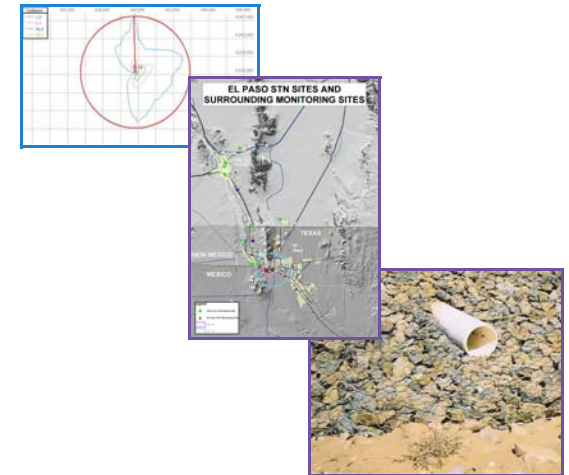

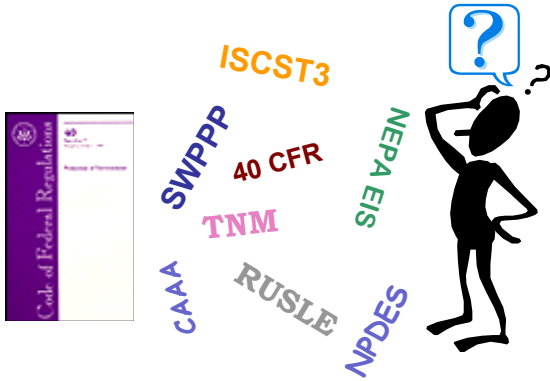

CLEAN WATER ACT (CWA)

Did you know that if your development site is one acre or more, or even if an individual home site is less than one-acre but part of a larger development, you need a Storm Water Pollution Prevention Plan (SWPPP)?

You may be subject to the EPA NPDES Storm Water Program and need a permit if you own an industrial facility.



If You do not have an SWPPP and appropriate controls at your construction or industrial site, the US Environmental Protection Agency can impose a civil penalty up to \$27,500 per day for each violation and a criminal penalty as high as \$50,000 per day of violation.

Preparing an SWPPP and installing controls will allow your site to be in compliance with the Clean Water Act (CWA) and will cost you a fraction of the EPA penalty.
